



OPTICOMM JUNE CAMPAIGN JULY 2026 – TERMS & CONDITIONS

1. The Opticomm June Campaign Promotion July 2026 (Offer) is made available by Occom Pty Ltd (Occom) to eligible customers who meet the criteria set out in these Terms and Conditions.
2. The Offer provides a monthly plan fee discount on selected residential broadband plans when the applicable promo code is applied at sign-up and the order is accepted by Occom, subject to these Terms and Conditions.
3. The Offer is available for eligible orders placed from 10:00 PM 30th Jun 2026 until 11:59 PM on 31st Dec 2026 Sydney time (Offer Period), unless withdrawn earlier by Occom.
4. There is no separate activation deadline for this Offer. To qualify, you must complete sign-up before the end of the Offer Period and meet Occom's standard order, service qualification, and connection requirements.
5. Occom may withdraw, extend, or change the Offer at any time by ceasing to advertise it or updating these Terms and Conditions.
6. This Offer is only available on the selected residential plans listed under the eligible plan schedule in these Terms and Conditions (Eligible Plans).
7. The Offer is not available on business services, mobile services, home phone services, wireless broadband, legacy plans, or any other service not expressly listed as an Eligible Plan.
8. To be eligible for this Offer, you must: (a) be at least 18 years of age; (b) order the service at an eligible Australian residential service address; (c) be switching from an existing provider or be a qualifying new customer based on Occom's address search and service qualification process; or be an existing customer adding an additional fibre service; (d) place your order during the Offer Period; (e) use the correct promo code for the relevant carrier and plan; and (f) satisfy Occom's standard credit, identity, service qualification, and connection requirements.
9. The Offer is only available at selected eligible addresses where there is no active residential broadband service at the time of order submission.
10. A qualifying customer is one whose address is identified by Occom as eligible for a new residential service following Occom's address search and service qualification checks.

11. If you cancel the relevant service within the first 3 months from the service activation date, Occom reserves the right to recover any promotional discounts applied to the service. The recoverable amount will be calculated on a pro-rata daily basis, based on the difference between the standard monthly plan fee and the discounted monthly plan fee for the relevant Eligible Plan, for each day the discounted service was active. For example, if you cancel the Boost (fibre25) plan on day 25 after activation in a 30-day month, the recoverable amount would be: $(\$72 - \$47) \div 30 \times 25 = \20.83 .
12. The promotional discount recovery described in clause 11 will not apply where the customer cancels the service due to a major service failure.
13. Occom may accept or reject any application for the Offer at its reasonable discretion, including where the requested service is unavailable at the address, the order is incomplete, or the customer does not meet Occom's standard requirements.
14. Unless Occom expressly states otherwise, the Offer may only be used once per service, is not transferable, cannot be redeemed for cash, or refund, and cannot be used in conjunction with any other promotional offer, discount, referral benefit, bundled incentive, or credit.
15. The Offer only applies to the monthly plan fee for the relevant Eligible Plan and only for the discount period stated for that plan. After the promotional discount period ends, the standard monthly plan fee for that plan will apply unless the customer changes, cancels, or upgrades the service.
16. The Offer only applies to the monthly plan fee. Any modem, delivery, installation, activation, non-standard connection, relocation, late payment, cancellation, hardware, call, add-on, usage, or other applicable fees and charges continue to apply.
17. If you change to an ineligible plan, disconnect the service, or otherwise cease to meet the Offer requirements during the promotional period, Occom may remove the Offer from the date of the change or disqualification.
18. If you move address during the promotional period, continued access to the Offer will depend on service availability at the new address and whether the replacement service remains an Eligible Plan.
19. The Offer is subject to service availability, network qualification, and any access network requirements, including but not limited to Opticomm coverage limitations.
20. All standard Occom terms, policies, fees, and charges continue to apply, including Occom's Standard Form of Agreement, Critical Information Summaries, and other applicable service terms.
